Application Overview

Applying for AIUM Ultrasound Practice Accreditation is the same for both new and returning applicants:

• Collect the documentation and case studies on page 2 (Application Checklist) needed to supplement the online application. You will need to upload these items into the online application as you fill it in.

Accreditation Application Fee:

To estimate the cost of applying for accreditation, refer to our <u>current fee schedule</u>. The application fee will be calculated for you automatically at the end of the online application.

You will be prompted to enter payment information just before the final submission of your online application. You may do either of the following to submit your application:

- pay online by credit card (Visa, MC, AmEx, Discover), or
- indicate payment by check/money order to proceed

If paying by check/money order:

- include your <u>application submittal #</u> on or with the check <u>failure to provide this # may cause</u> a delay in the review of your application

The following items must be uploaded within your online application.

- copy of current medical license, or a print out of license verification from your state website
- copy of residency <u>AND/OR</u> fellowship certificate(s) not required for physicians on a prior application unless interpreting in a specialty not previously identified
- certificates for any ultrasound CME credits that were not earned through the AIUM, obtained in the specialties they interpret for your practice in which accreditation is sought:
 - Total and enter # of all non-AIUM CME into a single entry under each physician's CME section.
 - OB/GYN & MFM <u>Refer to FAQs</u> about how to claim ABOG MOC (Maintenance of Certification) credits
